A few notes on the project, this project focuses on Women Empowerment wherein we would be educating women and girls in the basics of fashion designing at a bare minimum cost of Rs 500/- per month per candidate for "Certification Course" and Rs 500/- per month per candidate for "Diploma Course" We would facilitate with "Certification Course", which consists of 3 months and "Diploma Course" which constitutes 6 months time frame. The sewing machine and curriculum has been provided by

SINGER INDIA LTD wherein, SINGER INDIA LTD and Mahavir college will bear the tutor cost in part.

With immense gratitude we are thankful to the management of Mahavir College who understood the strength of this endeavour and approved for the setup of this project in their college. A applaud to Mr Rajendra Lokhande - Principal, Mr K A Kapase - Chairman and Rtn Mohan Gargatte - Secretary of the institute who took the initiative right from allocation of space to getting students enrolled into the courses. It gives immense pleasure to announce that we have fully filled two batches consisting of 50 students and would start with the course from 6th February 2023.
